Dear Brett,

Thank you for your email. I sense that the purpose of my email may not have been fully grasped. I acknowledge that the council encourages applications from all members of the community and will engage in participating in available disability support programs and funding options. I will monitor the council website for a position for Lewis and we will assist him to apply.

However, I would like to address a separate issue. I believe the council should be actively working towards creating opportunities for individuals with disabilities to integrate into their diverse workplace. The focus should extend beyond providing positions available to the wider community. Relying solely on competition for such positions puts individuals with disabilities at a clear disadvantage. Instead, there should be a concerted effort to offer support in creating employment opportunities that are equitable.

A role designed to accommodate a person with a disability differs from standard positions. Hence, to achieve equity in employment opportunities across a diverse community, it is essential to incorporate special considerations when creating emerging positions accessible to individuals with disabilities seeking employment. Not all individuals with disabilities will fulfill every criterion listed for a job position, but that does not mean they are incapable of performing the job competently. Lewis serves as a prime example, having successfully completed 18 months of work placement and demonstrated his capability to perform the job to a high standard. I believe this highlights a gap in creating equal opportunities for all individuals.

As an example, companies such as Bunnings have taken steps to provide support in generating employment opportunities for individuals with disabilities. As a local government organisation, I believe that council should be at the forefront of leading the community in this initiative. I would like an opportunity to discuss this matter further with you and such could you please advise me of a time and date that would be convenient with you.
